

The purpose of this revision 1 of this Safety Information Notice is to extend its effectivity to the cabin and cockpit crew.

Airbus Helicopters currently participates in an investigation following an event that occurred during a hoisting

A hoist cable jammed a few meters from the helicopter fuselage when the hoisted persons were lifted.

During the securing phase of the hoisted persons, the hoist cable broke.

Initial observations during the inspection of the equipment showed an incorrect reeling of the cable around the cable drum.

A complete expertise is currently performed within the scope of this event to identify the root causes of this incorrect reeling and the cause that led to the cable rupture.

Without predicting the conclusions of the ongoing investigation, Airbus Helicopters reminds the good practices to all customers who use hoists: if the hoist cable jams or is incorrectly reeled, stop any action involving the reeling or unreeling of the cable and focus on the securing of the hoisted persons.
