STANDARD CONDITIONS APPLICABLE TO A REGISTRATION CERTIFICATE TO TRADE IN AND/OR POSSESS CONTROLLED ITEMS

1. This certificate serves as proof that the holder is registered with the NCACC Secretariat and authorized to trade in and/or possess controlled items as defined in the National Conventional Arms Control (NCAC) Act, (No. 41 of 2002), as amended.
2. The certificate holder remains responsible and accountable for all actions authorized by this certificate, regardless of the involvement of any other parties.
3. Information contained in this certificate is confidential and may not be disclosed for purposes other than activities related thereto or otherwise required by law.
4. This certificate is not transferable, only the certificate holder shall trade in and/or possess controlled items listed in accordance with the stipulations contained herein.
5. This certificate does not constitute an authority directly or by implication to enter into any contract, or for the marketing, or the supply of controlled items or related services or technologies and to any other party.
6. This certificate is only valid in its original form and may only be used for the intended purpose as specified in the certificate and during the period of validity thereof as specified on the certificate. It is the responsibility of the certificate holder to submit a request for extension/renewal three (3) months before the current certificate expires.
7. Requests for both administrative and material changes to any of the particulars contained in this certificate must be submitted to the Secretariat in writing. Any UNAUTHORISED changes to this certificate will render it invalid.
8. In the event this certificates' validity period expires, by implication it invalidates all subsequent permits and authorizations obtained prior to the expiry of this certificate. The certificate holder must return the certificate as well as corresponding permits to the Secretariat with a letter requesting the cancellation of the certificate and said permits.
9. This certificate may at any stage without any liability to the State be cancelled or suspended by the NCACC in accordance with the provisions of section 14 (3) of the NCAC Act (No. 41 of 2002), as amended. If the certificate is cancelled in terms of section 14 (3) of the Act, the original certificate must be returned to the Secretariat.
10. If the certificate is cancelled by the certificate holder, the original certificate must be returned to the Secretariat with a letter requesting the cancellation of the certificate.
11. The certificate holder may within seven days of receipt of this certificate submit written objections to any of the conditions contained herein.
